Overview of the Standard Treatment Guidelines and Essential Medicines List



The Primary Healthcare (PHC) and Adult Hospital Level (AHL) Standard Treatment Guidelines (STGs) and Essential Medicines List (EML) provide a platform for transparency to enable equitable access to safe, effective, and affordable treatment options at both PHC and hospital level, taking into consideration the changing clinical needs of our population and the pragmatic implications of the introduction of a new health technology.







Standard Treatment Guidelines and Essential Medicines List



- Medicines are included or removed from the Essential Medicines List (EML) following an
 evidence-based review of safety and effectiveness and considering cost and other relevant
 practice factors.
- The South African Standard Treatment Guidelines (STGs) and EML review process is dynamic, and starts with prioritisation of chapters, medicines, or disease areas for review.
- The EML, STGs, and the reviews informing them are then updated and published on an ongoing basis.
- Each new review or update involves seeking input and comments from external stakeholders.
- All reasonable steps are taken **to align the STGs** with other National Department of Health guidelines available at the time of review.
- The current review cycle is 2020-4 and will replace the 2019 STGs & EML published for the Adult Hospital Level and 2020 STGs & EML for the Primary Healthcare
