

 The incumbent Ms Levani Naidoo commenced duties 1 November 2024 and will be responsible for driving the WCGHW Race to Net Zero 50 Action Plan.

Energy: Hybrid Inverter Rural Primary Health Care (PHC) Clinic Turnkey Project







 47 Hybrid Inverter installations completed at Rural PHC Clinics in 2023/24 (Including Ceres FPL).

4.2 WCHW 2024 MTEC Energy Plan

- WCHW Energy Services Company (ESCO) Energy Savings Pilot implemented at Red Cross Hospital, Paarl Hospital and Eerste River Hospital.
- o Total energy savings to date is 4 002 270 kWhrs.
- The total energy savings is enough to supply 285kWhrs to 13 759 homes for a year.
- o Total carbon savings to date is 3 921 245 Kg's.
- o 392 125 trees have been saved.
- o Total savings is R 7 133 913.
- 14 415 hours have been invested in skills development.
- 11 local Sub-Contractors and Suppliers have been utilized.
- Pilot is in process of being expanded to 12 hospitals in 2024/25.

Waste: Alternate Health Care Risk Waste Disposal System Turnkey Project







- Alternate Health Care Risk Waste Disposal Systems installed at:
 - Khayelitsha District Hospital
 - George Hospital
 - Paarl Hospital
 - Worcester Hospital
 - Karl Bremmer Hospital
 - Red Cross Hospital
 - New Somerset Hospital
- Converts Non-Anatomical Medical Waste into sterile disposable treated by-product which is environmentally friendly.
- In process of engaging National Forestries,
 Fisheries and Environment to dispose of the sterile
 by-product as normal household waste.















4. The Non-Anatomical HCRW treated at Newster (NW) Systems has generated savings on operational budget at project sites.



5. There has been a 50% reduction in the total HCRW expenditure across the six hospitals in the 2022/23 financial year compared to the 2021/22 financial year.










- Implementation of the WCGHW Race to Net Zero 50
