ACCESS TO STANDARD TREATMENT GUIDELINES AND ESSENTIAL MEDICINES LIST

PRIMARY HEALTH CARE (PHC) AND ADULT HOSPITAL LEVEL STANDARD TREATMENT GUIDELINES AND ESSENTIAL MEDICINES LIST

- The following have been reviewed and <u>ratified</u> by NEMLC, with the respective NEMLC report and appropriate medicine review(s):
 - PHC: Infections Chapter Malaria STGs NEMLC accepted the STG, supporting NEMLC report and evidence reviews for *final ratification*.
 - PHC: Obstetrics and Gynaecology Chapter NEMLC accepted the chapter and supporting report, as amended, for editing and <u>final ratification</u>.
 - Transdermal HT preparations medicine review NEMLC recommended that HT transdermal patches be removed from the chapter and be added to the therapeutic interchange database. The medicine review, amended chapter and report were accepted for <u>final ratification</u>.
 - PHC: Dental Chapter NEMLC accepted the chapter for editing and *final ratification*.
 - Adult Hospital Level: Obstetrics Chapter NEMLC accepted the chapter and supporting report, as amended, for editing and <u>final ratification</u>.
 - Nitrous oxide Aerolisation with nitrous oxide for pain was a concern in pregnant women with COVID-19, and was recommended for deletion from the STG/EML for this indication.
 - Adult Hospital Level: Gynaecology Chapter NEMLC accepted the chapter and supporting report, as amended, for editing and *final ratification*.
 - **Methotrexate** A concern was raised regarding the toxicity of methotrexate, and NEMLC recommended that a caution box be added (which was addressed electronically post-meeting).
- The following have been reviewed by NEMLC and ratified for *external comment,* with the respective NEMLC report and appropriate medicine review(s):
 - Adult Hospital Level: Mental Health Chapter Opioid Substitution Therapy (OST)
 - Methadone for OST medicine review NEMLC recommended that the review, OST STG and supporting NEMLC report with the amended OST checklist be disseminated for *external comment*. Until such time that service delivery is sufficient, MMT will be non-EML. However, NEMLC recommends that methadone be made available for pilot sites selected and monitored by the NDOH Programme. Data from such sites should inform further decisions regarding inclusion on the national essential medicine list for universal access.
 - **Buprenorphine for OST medicine review** NEMLC recommended that the review, OST STG and supporting NEMLC report with the amended OST checklist be disseminated for *external comment*.
 - **OST checklist amended** NEMLC recommended that OST STG and supporting NEMLC report with the amended OST checklist be disseminated for *external comment*.
 - PHC: Respiratory Chapter
 - Tuberculosis Prevention Therapy NEMLC accepted the recommendation not to use Tuberculosis Prevention Therapy (TPT) for household contacts. This recommendation and supporting documents have been accepted for <u>external comment.</u>
 - Drug-Resistant Tuberculosis Prophylaxis NEMLC accepted the recommendation not to use fluoroquinolones as prophylaxis for high-risk contacts of cases of active multi-drug resistant tuberculosis. This recommendation, as amended, and supporting documents have been accepted for <u>external comment</u>. NEMLC expanded the rationale to include that the "side-effect profile of long-term fluoroquinolone use and its possible impact on the development of drug resistance were concerns".

OTHER MATTERS

- PHC: Infections Chapter

Rabies – NEMLC accepted the proposal that i) Prevention of rabies: Pre-exposure prophylaxis (PrEP) and ii) Pre-exposure vaccination boosting not be included on the PHC EML and STG, but could probably be considered for NDoH Programmatic Guidance.

- PHC: HIV and AIDs Chapter

- NADIA and ARTIST trials evidence summary NEMLC accepted the evidence summary and recommended that this be shared with the NDoH Procurement Unit of the Affordable Medicines Directorate.
- Atazanavir/ritonavir medicine review amended NEMLC accepted the amended review and recommended that this be shared with the NDoH Procurement Unit of the Affordable Medicines Directorate.

- Adult Hospital Level: Blood and Blood-Forming Organs (BBFO) Chapter

 Proposal of Therapeutic Classes for Factor VIII and IX – NEMLC recommended that the matter be deferred for this tender cycle, and recommended that the Tertiary and Quaternary and Paediatric ERCs also review Factor VIII and IX as therapeutic classes.

- Adult Hospital Level: Nephrology Chapter

• **Doxazosin for Benign Prostatic Hyperplasia** – NEMLC recommended that a cost comparison be done between the immediate release formulation and the GITS formulation.

PAEDIATRIC HOSPITAL LEVEL STANDARD TREATMENT GUIDELINES AND ESSENTIAL MEDICINES LIST

- The following have been reviewed and <u>ratified</u> by NEMLC, with the respective NEMLC report and appropriate medicine review(s):
 - **Eye Conditions** NEMLC accepted the chapter for *final ratification*. The chapter will be sent for clinical editing and then publication.
 - **Paediatric Psychiatry** NEMLC accepted the chapter for *final ratification* following proposed changes.
 - **Endocrine** NEMLC accepted the chapter for *final ratification*.
- The following have been reviewed by NEMLC and ratified for *external comment,* with the respective NEMLC report and appropriate medicine review(s):
 - Adolescence NEMLC ratified the chapter for *external comment*.
 - Cardiovascular System NEMLC ratified the chapter for *external comment*.
 - Drug Allergies NEMLC ratified the chapter for *external comment*.
 - **Dermatology** NEMLC ratified the chapter for *external comment* following proposed changes.

External comment received from stakeholder by the 9 February 2022 due date will be reviewed by the Paediatric Expert Review Committee.
