# PRIMARY HEALTH CARE (PHC) AND ADULT HOSPITAL LEVEL STANDARD TREATMENT GUIDELINES AND ESSENTIAL MEDICINES LIST

- The following has been reviewed and *ratified for publication*, with the respective NEMLC report:
  - **PHC Chapter 13: Immunisation NEMLC** ratified the chapter for *publication*, with amendments.
- The following have been reviewed with the respective NEMLC report and relevant medicine review(s):
  - **PHC Chapter 5: Skin Conditions** NEMLC recommended amendments to the NEMLC report and supporting evidence prior to ratification.
  - Adult Hospital Chapter 4: Dermatology NEMLC recommended amendments to the NEMLC report and supporting evidence prior to ratification.
  - Adult Hospital Chapter 9: Systemic and Healthcare-Associated Infections NEMLC recommended editorial amendments prior to publication for external comment.
  - **Adult Hospital Chapter 15: Mental Health Opioid Dependence –** NEMLC recommended amendments to the treatment guidelines applicable for use in approved pilot sites only.

### PAEDIATRIC HOSPITAL LEVEL STANDARD TREATMENT GUIDELINES AND ESSENTIAL MEDICINES LIST

- The following have been reviewed and *published for external comment*, with the respective NEMLC report:
  - **Chapter 2:** Alimentary Tract NEMLC accepted the updated chapter and recommended the chapter be circulated for *external comment*.
  - **Chapter 8: Infectious Diseases -** NEMLC accepted the updated chapter and recommended the chapter be circulated for *external comment.*
  - **Chapter 9: HIV** NEMLC previously ratified this chapter, however the use of dolutegravir has been approved for use in the weight band 3 to 20 kg, and thus the chapter was updated accordingly.
