EVOLUTION OF THE ESSENTIAL MEDICINES LIST (EML) REVIEW PROCESS AND PRIORITISATION

- The Paediatric Hospital Level Expert Review Committee's (ERC) review cycle ended in 2023, the current terms for the Primary Healthcare/Adult Hospital Level ERC, the Tertiary and Quaternary Hospital Level ERC as well as the National Essential Medicines Lists Committee (NEMLC) are due to end in 2024.
- A proposed approach on evolving the NEMLC was agreed upon:
 - It was agreed that the 2023 edition of the Paediatric Hospital Level STGS and EML will not be disseminated for widespread comment nor a new Paediatric Hospital Level ERC constituted in the short-term. Work will focus on agreed upon priority areas for 2024 and issues addressed through the currently appointed NEMLC.
 - It was recommended that an Oversight Committee be formed to coordinate priority areas across ERCs for 2024. Furthermore, the Committee will work on activities to strengthen and evolve the EML review process in the short, medium and long-term.
 - Priority chapters/disorders identified were informed by several factors including PHC/Adult Hospital Level STG chapters not prioritised in the current review cycle, items deferred from the current ERC review cycles, expected upcoming National Department of Health Programme Guidelines updates, the Affordable Medicines Directorate's Tender Project Plan for 2024-6, and external stakeholder comments received for specific chapters. Some of the disorders identified as priorities for collaborative review include Respiratory, Endocrine and Eye Chapters.
 - Stakeholders are encouraged to inform the EDP of any safety issues that may be related to any of the published STGs and EML.

PRIMARY HEALTHCARE (PHC) AND ADULT HOSPITAL (AH) LEVEL STANDARD TREATMENT GUIDELINES AND ESSENTIAL MEDICINES LIST

- The following chapters have been reviewed and <u>ratified for external comment</u>, with the respective NEMLC reports and relevant medicine review(s). The commenting period closed on **03 April 2024**.
 - AH Chapter 16: Respiratory System
 - PHC Chapter 17: Respiratory Conditions
 - The following items were reviewed by NEMLC:
 - Isoniazid Preventative Therapy (IPT) safety in pregnancy Following a multi-stakeholder group meeting to discuss the evidence summary of IPT during pregnancy, a consensus recommendation was made that IPT should be deferred in all pregnant patients until after delivery to mitigate the risk of harm, and to simplify clinical guidance for ease of implementation. This recommendation was supported by NEMLC and will be reflected in the updated HIV chapters.
 - Enalapril night-time dose In response to an external query regarding the optimal dosing frequency and timing of administration of enalapril for the management of hypertension, a rapid review was undertaken and presented to NEMLC. NEMLC supported the recommendation that once daily administration of enalapril for the management of hypertension be retained in the EML. Furthermore, this should be prescribed at a time of day that is most convenient for the individual patient and that would optimise adherence and minimise side effects. The PHC and Adult Hospital level Cardiovascular chapters will be updated accordingly.
 - Penicillin desensitisation protocol A safety issue was raised post publication of the AH CH 26 Obstetrics, relating to the oral penicillin desensitisation procedure for penicillin allergic pregnant women with syphilis, as the oral desensitisation table did not include explicit instruction on the preparation of the oral penicillin doses and route of administration to be used. Therefore, the oral penicillin desensitisation table in the

- syphilis STG was clarified for preparation, dosing and administration of penicillin as part of a penicillin desensitisation protocol. It was also recommended that penicillin desensitisation occur in a setting where recognition and management of anaphylaxis can be assured. The corresponding section in the "How to Use These Guidelines" for oral and parenteral penicillin desensitisation, referred to in the Obstetrics chapter, has also been updated to provide specific instruction on preparation, route and dosing of penicillin for a penicillin desensitisation protocol.
- Haloperidol IM/IV availability Haloperidol IV/IM reintroduction as per historic indications in AH CH 15 and PHC CH 16 Mental Health Conditions was deliberated by the Committee due to recent availability. Haloperidol IM/IV was previously discontinued from the South African market and hence deleted from the STGs in the 2020-3 review cycle. The Committee considered the supply of Haloperidol IV/IM in the provinces, as well as the status of registration of the product by the South African Health Products Regulatory Authority (SAHPRA) in their decision-making. Due to the uncertainty of supply, at this time, NEMLC recommended that Haloperidol IV/IM not be reintroduced into the mental health chapters but be retained on the therapeutic interchange database as per historical indications.
- Tenofovir/ Alafenamide (TAF) The evidence review as previously approved by NEMLC was updated to include additional data with respect to the risks of weight gain, safety data in pregnancy as well as coadministration with rifampicin. The Committee supported that a TAF-containing fixed dose combination (either emtricitabine 200mg or lamivudine 300mg together with tenofovir alafenamide 25mg and dolutegravir 50mg) be added to the EML as an alternative to the current standard of care for PLHIV with hepatitis B coinfection and renal impairment (eGFR 30-50 ml/min/1.73m²). Additionally, TAF 25mg tablets will be added to the EML (AH Chapter 1 Section 1.2.4.2 chronic hepatitis B) for the small cohort of non-HIV infected hepatitis B patients with renal impairment (eGFR 15-50mL/min/1.73m² or on haemodialysis).

TERTIARY AND QUATERNARY HOSPITAL LEVEL ESSENTIAL MEDICINES LIST

- The following items were reviewed by NEMLC:
 - TNF Inhibitors fistulising Crohn's Disease NEMLC recommended that both infliximab and adalimumab be recommended for the management of fistulizing Crohn's disease. Adalimumab will be the preferred agent based on the cost; however infliximab will be available if an alternative is needed (e.g. in cases of antibody development). Guidance on therapeutic drug monitoring will be added as an annexure to the review document.
 - o **IV Bisphosphonates in secondary osteoporosis** The Adult Hospital Level STGs and EML currently recommend oral bisphosphonates for the secondary prevention of osteoporotic fractures. There is however a subset of patients where oral therapy may be contraindicated, and thus IV bisphosphonates are required. NEMLC approved the inclusion of IV bisphosphonates for this indication. IV bisphosphonates, zoledronate and ibandronate will be considered a class for this indication with the most affordable option procured. Currently IV zoledronate is the most affordable option.



HAEMOPHILIA SUBCOMMITTEE OF NEMLC

The following documents were presented for consideration by NEMLC:

• Emicizumab for prophylaxis in haemophilia A with inhibitors – NEMLC recommended that this agent not be approved at this time based on the price, affordability and availability of higher quality evidence with a bigger effect size. Although this product will not be listed on the EML, it can still be considered for use by Pharmaceutical and Therapeutics Committees on an individual patient basis.


