NOTICE: REPUBLICATION OF THE NATIONAL ESSENTIAL MEDICINES LIST (NEMLC) APPROVED UPDATES TO THE ADULT HOSPITAL LEVEL OBSTETRICS STANDARD TREATMENT GUIDELINES (STGs) (2020 TO 2023 REVIEW)

The Adult Hospital Level (AHL): Chapter 6, Obstetrics, was prioritised for review in the 2020 to 2023 AHL review cycle and initially published in January 2023.

In May 2024 NEMLC approved updates to the AHL Obstetrics chapter for republication with the following updates:

• 6.6 HIV IN PREGNANCY

 Guidance indicating that switching pregnant women from a TDF+FTC+EFV regimen to a TDF+3TC+DTG regimen requires a VL <50 copies/mL in the last 6 months was deleted from the STG in line with the 2023 National Department of Health Antiretroviral Therapy Clinical Guidelines.

6.7 SYPHILIS

O To promote safe practices, the oral penicillin desensitisation procedure for penicillin allergic pregnant women with syphilis was clarified in terms of dose, route of administration and the setting for administration. The corresponding section in the AHL "How to Use These Guidelines" for oral and parenteral penicillin desensitisation, referred to in the obstetrics chapter, has also been updated to provide specific instruction on preparation and route of administration. As the AHL STG 2020 to 2023 review cycle draws to a close and all STGs are collated for publication further updates to the AHL "How to Use These Guidelines" are anticipated and will be communicated.
